On November 5, 2020, this Court granted final approval to the class settlement and entered its Order Granting Final Approval of Class Action Settlement (Final Approval Order).

**IT IS HEREBY ORDERED, ADJUDGED, AND DECREED THAT:**

1. The settlement class is defined as:

All persons or entities who purchased one of the following Near East brand products in California from October 28, 2012 to May 8, 2020, excluding any purchase made for the purposes of resale, as well as Golden Grain, its officers, directors, management, employees, subsidiaries, and affiliates, and any judges or justices involved in this action and any members of their immediate families or their staff:

Couscous products: Broccoli & Cheese, Mediterranean Curry, Herbed Chicken, Parmesan, Roasted Garlic & Olive Oil Wheat Couscous, Toasted Pine Nut, Wild Mushroom & Herb, Roasted Garlic & Olive Oil Pearled Couscous, and Basil & Herb Pearled Couscous.

1 Rice pilaf products: Original Rice Pilaf, Brown Rice Pilaf, Lentil Rice Pilaf, Chicken  
2 Rice Pilaf, Spanish Rice Pilaf, Garlic & Herb Rice Pilaf, Roasted Chicken and Garlic Rice  
3 Pilaf, Original Long Grain and Wild Rice, Garlic and Herb Long Grain and Wild Rice,  
4 Roasted Vegetable & Chicken Long Grain & Wild Rice, Sesame Ginger Rice, Toasted  
5 Almond Rice Pilaf, and Wild Mushroom & Herb Rice Pilaf.

6 Quinoa products: Roasted Red Pepper & Basil, Rosemary & Olive Oil, Zesty Lemon and  
7 Mediterranean Medley.

8 Whole grain and tabbouleh products: Chicken & Herbs, Brown Rice Pilaf, Roasted Pecan  
9 & Garlic, Roasted Garlic & Olive Oil Wheat Couscous, and Tabbouleh Mix.

10 (“Near East Products”).

11 2. No Settlement Class Member objected to the settlement.


12 3. No class member requested to be excluded from the settlement.

13 4. Plaintiffs Virginia Gomez and Venus Savage and the settlement class shall take  
14 nothing from the complaint in this action except as set forth in (i) the Final Approval Order; (ii)  
15 the Second Amended Settlement Agreement and Release attached thereto; and (iii) the Order  
16 Granting in Part Plaintiffs’ Motion for Attorneys’ Fees and Costs and Incentive Awards, also filed  
17 November 5, 2020.

18 5. Pursuant to the Settlement Agreement and rule 3.769(h) of the California Rules of  
19 Court this Court retains jurisdiction over plaintiffs Virginia Gomez and Venus Savage, the  
20 settlement class, and defendant Golden Grain Company to enforce the terms of the Settlement  
21 Agreement, the Final Approval Order, and this Judgment.

22 IT IS SO ORDERED.
